



2020-2021 Waiver of Liability (Covid-19) – Must be Signed by all students. (No exceptions)

I, _____, hereby on this date of ___/___/2021 understand that COVID-19 (including variations and mutations) is a highly communicable virus that can cause, among other conditions, severe respiratory illness, sometimes leading to death, in individuals who contract it.

I understand and expressly agree that my participation in any other in-person Activities conducted or organized by or through Denise Carraro (LEAN COACH) involves the risk that I could contract COVID-19 notwithstanding the mitigation measures in place by Denise Carraro. I understand that these risks are inherent to my use of the facilities or participation in such Activities and can range from mild symptoms to major illness, including death. I further understand and voluntarily accept full responsibility on my behalf for the risk of contracting COVID-19.

I will not attend community classes or any other in-person Activities conducted or organized by or through Denise Carraro if I am exhibiting symptoms of COVID-19 (which can include fever, cough, shortness of breath or difficulty breathing, chills, repeated shaking with chills, muscle pain, headache, sore throat, new loss of taste or smell), or if I have been exposed to a third party who has exhibited COVID-19 symptoms in the 14 days preceding my participation in the Activities.

I understand that Denise Carraro cannot guarantee that I will not become infected with COVID-19. Further, attending community in-person activities and classes could increase your risk of contracting COVID-19. I, _____, am choosing to continue my classes with Denise Carraro. I understand that there are risks associated with my participation and I fully accept and release the instructor/organizer, Denise Carraro from any responsibility related to any likelihood of contracting COVID-19 during my visit.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I may be exposed to or infected by COVID-19 by attending Denise Carraro community classes and Activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. On my behalf, I hereby release, covenant not to sue, discharge, and hold harmless the facility, the instructor and/or owner of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the facility, instructor and/or owner, whether a COVID-19 infection occurs before, during, or after participation in any of the community classes or Activities.

I/WE HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I /WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
